CIF CLASS A AND B SECURITIES TRADE AS ORDINARY SECURITIES

1 July 2008, Sydney – Challenger Infrastructure Fund (ASX: CIF) announced as of today both class A and class B securities will become and trade as ordinary securities in accordance with their terms of issue.

CIF now has 348,532,835 ordinary securities trading on ASX. All ordinary securities have the same entitlements, including as to distributions and tax deferral status.

CIF's FY2009 distribution is forecast to be 35.7 cents per security. As announced on 22nd May 2008, FY2009 distributions are no longer partially debt funded and instead comprise the following:

- More than 90% to be funded from operating cashflows
- The remainder to be funded from retained cash balances held by the Fund and its assets

The FY2009 distribution is expected to be approximately 35% tax deferred.

The distribution profile reflects the strong underlying cash generation of the existing asset portfolio and is expected to be maintained for the FY2010 distribution¹. CIF has targeted distribution growth of 5% for FY2010¹.

CIF is an Australian publicly listed global diversified infrastructure fund that invests in regulated and contracted monopoly-like assets. CIF has a portfolio of assets which are diversified by sector and also geographical location and focuses on countries with relatively stable political and regulatory environments. CIF takes a disciplined approach to the types of assets in which it invests in order to provide security holders with a predictable and stable yield with the additional benefit of potential capital growth. CIF's portfolio is diversified across three key assets: Inexus, Southern Water and LBC.


